

# How Guzman y Gomez instantly reports month-end close in Excel with Solution 7 by Zone

**Guzman y Gomez (GYG)**, is a fast-growing quick-service restaurant brand bringing Mexican-inspired cuisine to more than 250 locations across Australia, the United States, Singapore and Japan. As the company prepared for life as a newly listed organization on the ASX, its finance team faced mounting challenges with month-end reporting across hundreds of entities. Manual data exports, spreadsheet manipulation and fragmented processes were delaying their month-end close. To keep pace with rapid growth, GYG needed a solution that could deliver accurate, presentation-quality reports instantly using live NetSuite data.

With **Solution 7 by Zone**, GYG transformed its close process – cutting five days from month-end reporting and giving leadership real-time visibility into performance across every restaurant.

### **The Challenge: Manual reporting processes slowed month-end close across hundreds of restaurants**

As GYG expanded its global footprint, the finance team struggled to keep up with the increasing complexity of its reporting requirements. Each month-end close involved downloading large volumes of data from NetSuite, manipulating spreadsheets, and manually consolidating results across more than 250 restaurant entities.

Each location generated its own revenue, cost and performance metrics, creating layers of intercompany transactions and multi-entity consolidation needs.
- ◆ **Pressure from public listing:** As a newly listed company on the Australian Securities Exchange (ASX), GYG faced heightened expectations for transparency and timeliness. Management needed fast, accurate insight into performance at both entity and group levels.

### The Solution: Live reporting in Excel

After evaluating their options, GYG chose Solution 7 by Zone – a native Excel plugin that connects to live NetSuite data for analysis and reporting.

Guzman y Gomez partnered with Zone to bring real-time visibility into its financial reporting.

Solution 7, a NetSuite SuiteApp, functions as a native plug-in within Excel, complete with its own tab in the top ribbon. Its familiar Excel interface lets finance teams create, refresh and analyze reports all within the tool they know. No exports, extra steps or navigating NetSuite’s backend needed.

Excel reports across entities, countries and restaurant locations stay synchronized with live NetSuite data, and users can drill back and drill down into detailed transactions without leaving their workbooks. What was once a time-consuming, error-prone process has become a fast, reliable system built to scale with Guzman y Gomez’s global ambitions.
